ADI has been carefully monitoring the spread of the Omicron variant of COVID-19. We have made the decision to revert back to all services being provided via telehealth, only, until further notice. While we have enjoyed seeing everyone in person again over the last few months, this decision came with ease and without question in an effort to protect the health and safety of both our clients and our staff. **Beginning Tuesday, January 4th, 2022 (We are closed Monday in observance of the New Year), all services will be held virtually over Zoom.** This includes all intake evaluations, group and individual sessions. You may contact your counselors via email or call the office if you need the Zoom info for your session.

Staff will be in the office during office hours ONLY to answer phones, schedule appointments, etc. The only time others should be in the building is to complete paperwork needed for scheduling an intake appointment or current clients submitting urine samples for testing as directed. As always, while in the building, everyone is required to wear a mask or other face covering that fits over the nose and mouth, regardless of vaccination status. ADI will provide a mask if you do not have one, while supplies last. Failure to comply with this requirement will result in you being asked to leave the building.

As always, no one is permitted in the building other than current clients or those seeking treatment for confidentiality purposes.

Happy sunny Saturday everyone!

ADI had begun planning and hoped to re-open for in person services on October 26th. However, after much input from both our clients and our staff members, ADI has opted to continue with telehealth services instead. Telehealth will continue as it has been throughout the remainder of 2020. The health and safety of both our clients and our staff remains of top priority to us and we feel that, overall, the pros of telehealth outweigh the cons at this point in time.

As a reminder to all clients: when agreeing to participate in telehealth services, you are agreeing to ALL telehealth procedures, which includes electronic communication via the email address you have provided to us. This means that you are agreeing to receive communication by email regarding your treatment, which includes drug screening. It is imperative that you check your emails daily for any communication from us.

As always, failure to report for a drug screen as requested may result in a “behavior positive”, which is treated the same as a positive urine/breath/oral fluid result and could ultimately cause an increase in treatment.

We understand that a lot of our clients are employed, have children, etc., and may need to make arrangements to get here as requested. To help with this, we have extended our drug screening hours from 4:00 pm to 5:30 pm, on Tuesdays and Thursdays only. Mondays and Wednesdays will remain with a 4:00 pm cutoff time.

No one other than current clients or those seeking treatment are permitted to be in the building at any time. Anyone reporting to the office is required to wear a face covering. If you cannot abide by these rules, you will be asked to leave.

In the event that you have any questions or concerns, please contact the office at 410-787-2288. Administrative office/phone hours will remain 10:00 am to 5:00 pm Monday through Thursday. The office is closed completely on Fridays, Saturdays and Sundays. You may leave a voicemail during non-office hours and someone will return your call as soon as possible. In the event of an emergency, please call or text 9-1-1.

The federal Public Health Emergency has been extended. Under Section 319 Under the Public Health Service Act, this extension is good for 90 days, and may be further extended, or until the Secretary declares the Public Health Emergency no longer exists.

ADI will continue the good faith provision of services by continuing with telehealth using audio/video technology.

Clients will continue to be randomly called into the office for drug screening only and are expected to comply with this request, while doing so as safe and proficient as possible. Anyone entering the building is required to wear a mask or other face covering. Clients are to be seated in the downstairs lobby area, maintaining social distance, until called upon. No one should be waiting in line for the bathroom. No one other than current clients or those seeking treatment are permitted inside of the building under any circumstance and will be asked to leave. This includes your ride, children, friends, family members, etc. Please provide accommodation for those people prior to coming in.

With the rapid increase in positive COVID-19 cases in our area, ADI has decided to take additional precautions on top of our daily disinfecting and close the office on Monday, 3/30/20, for a deep cleaning to ensure that all high traffic areas are thoroughly sanitized and disinfected.

While our teletherapy sessions were scheduled to officially launch on 3/30/20 and clients would not be present in the office, essential employees were still required to report to the office to perform these duties. To ensure the safety of everyone, essential employees will not be in the office during this closure. As such, all teletherapy sessions and intake assessments scheduled for Monday, 3/30/20, have been CANCELLED at this time.

ADI will be in touch with those who have intake assessments scheduled to reschedule a virtual assessment for them, eliminating the need for them to come into the office. **Going forward, we will no longer be allowing anyone seeking treatment to walk into the office. However, WE ARE STILL HERE TO HELP! If you are seeking mental health or substance abuse treatment - outpatient, inpatient or detox, we ask that you please call our office at 410-787-2288! Intakes will be easier than ever from the comfort of your home via telephone.**

Office Hours going forward will be Monday - Thursday 10:00 am to 6:00pm.

Clients who were scheduled to begin teletherapy group sessions on Monday 3/30/20 will resume their sessions next week. Those who have multiple group sessions per week will attend their next session as scheduled.

Per our previous announcement, we are diligently working on implementing the use of teletherapy due to the COVID-19 pandemic. We plan to have all staff/ clients trained on how to use this virtual technology in the coming week so that we can implement all virtual services beginning Monday, March 30th. Anyone who has not physically been into the office prior to the virtual start date will be contacted by their counselor to get a working email address and give them instructions on how to participate.

Please be aware that all normal group/ one-on-one session rules will still apply in the virtual sessions. You will be expected to attend as well as participate in all discussions and activities.

The late policy will still apply. If you enter the session past the usual 5 minute grace period, you will be removed from the session and not get credit. We are trying our best to keep as much normalcy as possible during this time. Any inappropriate behavior in the virtual sessions will not be tolerated. Provided that there are no government issued restrictions, you may still be called into the office for a random urinalysis, oral swab or breathalyzer. In this case, you would be expected to comply and report for testing as a part of your treatment.

FOR SELF PAY CLIENTS : ADI has set up a PayPal account so that you may pay for your sessions from the comfort of your home. Due to changing office hours and limited staff, we will only be reconciling payments once per week. What does this mean for you? This means that we will send you an invoice for your group session(s) for the week as well as any past due balance you may have. **YOU MUST MAKE PAYMENT BY THURSDAY AT 9:00 PM** each week. No matter what day of the week you are scheduled, you will have until Thursday at 9:00 pm to pay without any penalty. However, please be aware that any payment received after Thursday at 9:00 pm will **not** be applied to your account until the following week. **Individual sessions will be required to be paid for prior to your session or you will not be seen.** As of now, our rule regarding balances will still apply. If you have not paid or pay past the weekly payment deadline and it causes your balance to accrue over \$90.00, you will not be permitted to attend the next scheduled virtual session, just as you would not be permitted to attend an in-office session. If you are having difficulty paying during this time, please contact Jessica C. by phone or email (jcollison@adintervention.org) to discuss possible options. As always, you will be notified in the event that our payment policy changes in the future.

As we continue to get more information about COVID-19 and more restrictions begin to be put in place by both the state and federal governments, ADI is looking for ways to ensure the health and safety of our staff and clients.
